DIRECTIONS

GREENS / TEES / LAWNS.: Mix 16 OZ with OCEAN MIST with sufficient water to cover, per 5000 FT2. Mix in tank with any fertilizer spray mix and follow spray directions for applications. Row Crops: Mix 8 OZ with OCEAN MIST24 with sufficient water to cover, per acre. Mix in tank with any fertilizer spraymix and follow spray directions for applications.

Fruit Trees/ Citrus:/ Mix 42 OZ OCEAN MIST with sufficient water to cover, per acre. Mix in tank with any fertilizer spray mix and follow spray directions for applications. should be incorporated with any well balanced fertilizer program.
